## New Mexico COVID-19 update: 314 new cases, totaling 183,335 Nine additional COVID-19 deaths

SANTA FE – New Mexico state health officials on Tuesday announced 314 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Tuesday reported nine additional deaths in New Mexico related to COVID-19:

- A male in his 50s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A second male in his 50s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A male in his 60s from Bernalillo County. The individual had underlying conditions.
- A male in his 50s from Curry County. The individual was hospitalized and had underlying conditions.
- A female in her 90s from Doña Ana County. The individual was hospitalized.
- A male in his 70s from Lea County. The individual was hospitalized and had underlying conditions.
- A male in his 60s from McKinley County. The individual was hospitalized and had underlying conditions.
- A male in his 70s from Otero County. The individual was hospitalized and had underlying conditions.
- A male in his 60s from San Juan County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 3,644.

The ten ZIP codes across the state with the most COVID-19 cases on Tuesday, Feb. 23 are:

Daily case counts and test numbers are raw data based on information the state receives today - meaning data that has not yet been scrutinized to identify potential duplicates or late-arriving positives or negatives. By contrast, the <u>Red</u> <u>Yellow Green county-level analysis</u> provides a highly accurate picture for a two-week period of time.

Previously reported numbers included and two cases that were not lab confirmed (one in San Miguel County and one in Sandoval County)-- these have now been corrected. Including the above newly reported cases, New Mexico has now had a total of 183,335 COVID-19 cases:

As of today, there are 261 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 135,608 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The Department of Health has detected community spread in the state of New Mexico and is investigating cases with no known exposure. The agency reports that given the infectious nature of the virus it is likely other residents are infected but yet to be tested or confirmed positive. To that end, <u>all New Mexicans have been instructed to stay home except for outings absolutely necessary for health, safety and welfare</u>. These additional restrictions have been enacted to aggressively minimize person-to-person contact and ensure spread is mitigated. New Mexicans are strongly urged to limit travel to only what is necessary for health, safety and welfare.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact-tracing and swabs of symptomatic individuals who have had contact with the positive cases.

Every New Mexican must work together to stem the spread of COVID-19. <u>Stay</u> <u>home, especially if you are sick. Wear a mask or face covering when in public and around others.</u>

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
