New Mexico COVID-19 update: 273 new cases, totaling 208,243
Two additional COVID-19 deaths

SANTA FE – New Mexico state health officials on Thursday announced 273 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Thursday reported two additional deaths in New Mexico related to COVID-19:

- A male in his 50s from Eddy County.
- A female in her 60s from Eddy County. The individual had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 4,394.

As of today, there are 98 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 196,373 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The Department of Health has identified at least one positive COVID-19 case in residents and/or staff in the past 28 days at the following long-term care facilities:

- Fort Bayard Medical Center in Santa Clara
- Genesis Healthcare Uptown in Albuquerque
- Good Samaritan Society – Betty Dare in Alamogordo
- Laguna Rainbow Care Center in Casa Blanca
- Lakeview Christian Home in Carlsbad
- Las Palomas Center in Albuquerque
- The Neighborhood in Rio Rancho Assisted Living in Rio Rancho
- Sierra Health Care Center in Truth or Consequences
- Skies Healthcare and Rehabilitation Center in Albuquerque

The New Mexico Department of Health has active investigations into the positive patients, which includes contact tracing and swabs of symptomatic individuals who have had contact with the positive cases.

Every New Mexican must work together to stem the spread of COVID-19. **If you are sick or unvaccinated, wear a mask when in public and around others.**

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;

- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
