## New Mexico COVID-19 update: 2,286 new cases, totaling 231,785

Seven additional COVID-19 deaths - Saturday, August 28, Sunday, August 29, and Monday, August 30

SANTA FE – New Mexico state health officials on Monday announced 2,286 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The number of deaths of New Mexico residents related to COVID-19 is now 4,512.

Daily case counts and test numbers are raw data based on information the state receives today - meaning data that has not yet been scrutinized to identify potential duplicates or late-arriving positives or negatives. Previously reported numbers include one case in Doña Ana County that has been determined to be an out-of-state resident - this has now been corrected.

As of today, there are 394 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 202,111 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact tracing and swabs of symptomatic individuals who have had contact with the positive cases.

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
