New Mexico COVID-19 update: 994 new cases, totaling 234,475 Fifteen additional COVID-19 deaths

SANTA FE – New Mexico state health officials on Thursday announced 994 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

- A female in her 60s from San Juan County. The individual had underlying conditions.
- A second female in her 60s from San Juan County. The individual was hospitalized and had underlying conditions.
- A male in his 70s from San Juan County. The individual was hospitalized and had underlying conditions.
- A female in her 80s from San Juan County. The individual was hospitalized and had underlying conditions.
- A male in his 80s from Socorro County. The individual was hospitalized and had underlying conditions.
- A male in his 30s from Valencia County. The individual was hospitalized.
- A female in her 60s from Valencia County. The individual was hospitalized and had underlying conditions.

One* death >30 days:

• A female in her 50s from Sandoval County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 4,544.

*COVID related deaths are reported when a death certificate has been issued and some death certificates are delayed due to insufficient information.

Additional note on vaccines: due to an unforeseen technical issue, the COVID-19 vaccine dashboard will not be updated today. We aim to publish updated vaccine numbers tomorrow.

As of today, there are 392 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 203,156 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
