**New Mexico COVID-19 update: 1,525 new cases, totaling  
246,229**

*Fourteen additional COVID-19 deaths - Saturday, September 18,  
Sunday, September 19, and Monday, September 20*

SANTA FE – New Mexico state health officials on Monday announced 1,525 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Monday reported fourteen additional deaths in New Mexico related to COVID-19:

Eleven recent deaths:

- A male in his 20s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A male in his 30s from Bernalillo County. The individual was hospitalized.
- A female in her 50s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A male in his 60s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A female in her 80s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A male in his 80s from Bernalillo County. The individual had underlying conditions and was a resident of the MorningStar Memory Care facility at North Ridge in Albuquerque.
- A second male in his 80s from Bernalillo County. The individual was hospitalized.
- A female in her 90s from Lea County.
- A female in her 60s from Lincoln County. The individual was hospitalized.
- A male in his 60s from Sandoval County. The individual was hospitalized.
- A male in his 70s from Sandoval County. The individual was hospitalized and had underlying conditions.

Three\* deaths >30 days:

- A female in her 40s from Lea County.
- A male in his 90s from Lea County. The individual had underlying conditions.

- A male in his 60s from Valencia County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 4,689.

\*COVID related deaths are reported when a death certificate has been issued and some death certificates are delayed due to insufficient information.

Daily case counts and test numbers are raw data based on information the state receives today - meaning data that has not yet been scrutinized to identify potential duplicates or late-arriving positives or negatives.

As of today, there are 310 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New

Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 215,480 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
