**New Mexico COVID-19 update: 3,794 new cases, totaling  
324,311**

*Twelve additional COVID-19 deaths, 7-Day positivity rate 13.9%  
Saturday December 4, Sunday December 5, and Monday December 6*

SANTA FE – New Mexico state health officials on Monday announced 3,794 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Monday reported twelve additional deaths in New Mexico related to COVID-19:

Ten recent deaths:

- A male in his 30s from Bernalillo County. The individual was hospitalized.
- A male in his 50s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A male in his 70s from Bernalillo County. The individual had underlying conditions.
- A male in his 90s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A female in her 70s from Curry County. The individual was hospitalized.
- A male in his 30s from Eddy County. The individual was hospitalized.
- A male in his 60s from Luna County.
- A male in his 80s from San Miguel County. The individual was hospitalized.
- A male in his 50s from Valencia County. The individual was hospitalized and had underlying conditions.
- A male in his 70s from Valencia County. The individual was hospitalized and had underlying conditions.

Two deaths > 30 days:

- A female in her 80s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A female in her 70s from Doña Ana County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 5,419.

\*COVID related deaths are reported when a death certificate has been issued and some death certificates are delayed due to insufficient information.

As of today, there are 632 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 273,577 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact-tracing and swabs of symptomatic individuals who have had contact with the positive cases.

Every New Mexican must work together to stem the spread of COVID-19. Wear a mask when in public and around others. If you are sick, stay home as much as possible.

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
