New Mexico COVID-19 update: 2,561 new cases, totaling 332,238

Twelve additional COVID-19 deaths, 7-Day positivity rate 10.6%

Saturday, December 11, Sunday, December 12, and Monday, December 13

SANTA FE – New Mexico state health officials on Monday announced 2,561 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

- A male in his 70s from San Juan County. The individual was hospitalized and had underlying conditions.
- A female in her 50s from Santa Fe County. The individual had underlying conditions.
- A female in her 60s from Torrance County. The individual was hospitalized and had underlying conditions.
- A female in her 90s from Valencia County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 5,484.

As of today, there are 610 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently

hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 283,030 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact-tracing and swabs of symptomatic individuals who have had contact with the positive cases.

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
