## Interstates:

### I-25 & University Ave, Mile Marker 1, Las Cruces

La Calerita Construction, LLC (Contractor) project is now substantially complete. The contractor will continue to work on a list of final required construction activities. Expect intermittent shoulder and lane closures as needed. Regular work hours are Monday-Friday, 7 a.m.-5 p.m., Questions, comments, or concerns: visit <u>www.i25-university.com</u>.

### I-25, Mile Marker 34 to 39, Rincon ON110102

Mountain States Constructors, Inc. (Contractor) will be continuing a roadway reconstruction project on I-25 north of Las Cruces. A detour crossover will be in place, all traffic will be shifted into the southbound lanes utilizing crossover detour and barrier wall separation. The Rincon, exit 35 northbound on and off ramps will be closed, southbound exit is open, follow detour signage. Hours of operation will be from 7 a.m. to 5 p.m., Monday through Friday. Traffic control will remain in place 24/7.

### I-10, Mile Marker 21 to 23, Lordsburg

AUI, Inc. (Contractor) is currently working on the bridge deck on the eastbound lanes. Traffic is currently rerouted to the eastbound I-10 lanes as the contractor begins construction of the westbound I-10 bridge. Detour signs will be in place to direct traffic towards alternate routes. Animas St. will be unaffected and can be utilized in place of Main St. Daily hours of operation are 7 a.m. to 5 p.m., Monday through Friday. Traffic control will remain in place 24/7.

### I-10, Mile Marker 24.9 to 35, Lordsburg

Mountain States Construction, Inc. (Contractor) will be continuing a pavement preservation project on I-10 from milepost from milepost 24.9 (Lordsburg East) to milepost 35. Drivers can expect overnight lane closures on both the eastbound and westbound lanes as needed. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Friday. Construction is expected to be completed winter of 2021.

## <u>US Roadways:</u>

### US 180, Mile Marker 86 to 111, Cliff to Silver City

US 180 from milepost 86 to 111, traffic will encounter lane drops with pilot car and flagging operations for Fog Sealing. Speed limits will be reduced with no center stripe. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area. This project is estimated to be completed Spring 2022.

### US 70, Mile Marker 166-168, Las Cruces/San Augustine Pass

The New Mexico Department of Transportation (NMDOT) will be performing roadway repairs due to flooding on US 70 from milepost 170 to 168. Lane closures will be in place on the eastbound and westbound passing lanes as needed, speed limits will be reduced to 45 mph. Closures will be in place Monday through Thursday from 8:00 a.m. until 4:30 pm until December 20, 2021.

# <u>State Roadways:</u>

### NM 26 Hatch Hwy, Mile Marker 10 to 14, Florida

NM 26 milepost 10 to 14 will have intermittent roadway closures for highway filming. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area. Seek an alternate route if possible. This closure will be in place Tuesday, December 14, from 9 a.m. until 5 p.m.

### NM 273 Mile Marker 2, Sunland Park

The New Mexico Department of Transportation (NMDOT) will be performing roadway repairs on NM 273 "McNutt Road" at milepost 2. The driving right lane is expected to be closed through December 30<sup>th</sup>. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area.

### NM 404 and I-10 Bridge Replacement, Anthony E100202

AUI, Inc. (Contractor) is continuing with roadwork and replacement of the NM 404 Bridge over I-10 at milepost 162, Anthony exit. Traffic is open to one lane in each direction. Daily contractor hours of operation are from 7 a.m. to 5 p.m., Monday through Saturday. Traffic control will remain in place 24/7.

### NM 187 "El Camino Real", Mile Marker 23.5, Caballo

NM 187 milepost 23.5 (Greenhorn Arroyo) crews will have an intermittent flagging operation in place for roadway repairs. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area. This closure will be in place Monday, December 13, 2021, to Thursday, December 16, 2021 for 8 a.m. until 5 p.m. daily.

### NM 187 "El Camino Real", Mile Marker 16.93 to 31.1, Arrey-Caballo CN1101

FNF Construction, Inc. (Contractor) is continuing with replacement of Bridges located in Arrey and Caballo. A shoo-fly diversion is in place at Seco Creek (MP 26.6). NM 187 is completely open to traffic. Contractor's hours of operation will be from 7:00 am to 5:00 pm Monday to Friday.

# City of Las Cruces Projects:

### Peachtree Hills Road

Due to storm drain upgrades as part of new residential development, Peachtree Hills Road between Sonoma Ranch Boulevard and Metro Park Street will be closed while Renegade Construction, LLC places concrete box culverts. A detour will be in place throughout the duration of the construction and traffic will be guided through Sirocco Avenue and Metro Park Street.
