Members of the Citizen Redistricting Committee presented to the Senate Rules Committee, additional senators, and the public. The members were widely praised for their work by the senators. Thank you to CRC Chairman Justice Ed Chavez and CRC members Lisa Curtis and Robert Rhatigan for their presentation and hard work.

We have been informed that various Native American contingents reached consensus on a Congressional, NM House & Senate and a PEC map. Those maps were filed as bills in the House of Representatives yesterday. The CRC presents again today to the House of Representatives at approximately 9:30 or 10am. The New Mexico House CRC maps were filed as bills by Representatives Daymon Ely and Wonda Johnson yesterday. An additional map was filed by Representative Ely. Those maps are scheduled to be heard today at 1:30 in House State Government, Elections, and Indian Affairs Committee [Details and how to join here](#). [Watch proceedings here](#).

Senate Rules meets today at 9:30am. Some maps will be presented. We don't know which ones. Public comment will not be taken in the Senate until Thursday this week, once bills have been introduced. [Link for agenda and info to join](#).

While some maps are being introduced in Senate Rules today, we do not yet have an indication that the CRC maps are being filed in the Senate. This is causing concern among us as we proceed to the Capitol today, day 2, and will be our first pursuit upon arrival.
