New Mexico COVID-19 update: 6,919* new cases, totaling 388,215

Twenty-eight additional COVID-19 deaths, 7-Day positivity rate 27.4%

*Please note: Today's reporting was impacted by the temporary disruption in the electronic lab feed. Approximately, 1,000 new COVID-19 cases were received after resolution of the electronic lab reporting disruption and are included in today's COVID-19 epidemiology report. An additional 2,540 new cases were reported by one laboratory, and these include cases that were recently tested over the past 12 days. These new cases just reported to the state are also included in today's epidemiology report.

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
