## MEDIA ADVISORY: NMPRC to hold public comment hearing regarding the cost-benefit analysis of PNM's proposed grid modernization plan

**SANTA FE** – The New Mexico Public Regulation Commission (NMPRC) will hold a public comment hearing regarding the cost-benefit analysis and supplemental testimony of Case No. 22-00058-UT: In the matter of rPublic Service Company of New Mexico's (PNM) application for authorization to implement grid modernization components that include advanced metering infrastructure and application to recover the associated costs through a rider, issuance of related accounting orders, and other associated relief. Written comments may also be submitted at any time in this case before the Commission takes final action. Public comments will not be considered as evidence in this proceeding.

PNM submitted its application for grid modernization in October 2022. Last year, the NMPRC issued an order for PNM to submit a supplemental cost-benefit analysis of the application's proposed investments. PNM collaborated with a third-party consulting firm to produce the cost-benefit analysis, which was provided to the Commission in November 2023. A supplemental hearing for this case, focusing on the cost-benefit analysis and testimony provided in support of the document, is scheduled for April 23 and 24, and will be available to watch online.
