## NMPRC to hold informational meeting to assess investor-owned utilities' upcoming summer energy plans

**SANTA FE** – The New Mexico Public Regulation Commission (NMPRC) on Friday, April 19, will hold an informational meeting with the state's three investor-owned utility companies (IOUs) to assess their summer energy plans and the necessity for reliable service during peak demand periods.

During the meeting, Public Service Company of New Mexico (PNM), Southwestern Public Service Company (SPS), and El Paso Electric Company (EPE) each will present on their upcoming seasonal planning strategies, focusing on the following key areas:

- Resource Adequacy and Summer Planning: The IOUs will present strategies for ensuring resource adequacy during peak summer months, including operational plans for both peak and off-peak periods.
- Cost Projections and Risks: The IOUs will outline their projected energy costs for the summer, segmented monthly, and identify potential risks affecting these projections.
- Miscellaneous: The IOUs will provide examples of how feedback from previous discussions, proceedings, presentations, and rulemakings may have been integrated into their current summer preparedness strategies.

The insights gained from the informational meeting will aid in the Commission's ongoing efforts to ensure service reliability and protect the interests of ratepayers.

The Commission might hold additional informational meetings in the fall and spring of each year to address winter energy planning strategies for the IOUs.
