**New Mexico COVID-19 update: 2,201 new cases, totaling
225,994**

*Nine additional COVID-19 deaths - Saturday, August 21, Sunday,
August 22, and Monday, August 23*

SANTA FE – New Mexico state health officials on Monday announced 2,201 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Monday reported nine additional deaths in New Mexico related to COVID-19:

- A male in his 70s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A female in her 20s from De Baca County. The individual was hospitalized.
- A female in her 70s from Eddy County.
- A second female in her 70s from Eddy County. The individual was hospitalized.
- A male in his 70s from McKinley County. The individual was hospitalized and had underlying conditions.
- A female in her 90s from San Juan County. The individual was hospitalized and had underlying conditions.
- A male in his 90s from San Juan County. The individual was hospitalized and had underlying conditions.
- A male in his 60s from Santa Fe County. The individual was hospitalized and had underlying conditions.

One* death >30 days:

- A female in her 70s from Bernalillo County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 4,481.

* COVID-related deaths are reported when a death certificate has been issued and some death certificates are delayed due to insufficient information.

As of today, there are 352 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 200,060 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact tracing and swabs of symptomatic individuals who have had contact with the positive cases.

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
