**New Mexico COVID-19 update: 412 new cases, totaling 246,639**  
*Eleven additional COVID-19 deaths*

SANTA FE – New Mexico state health officials on Tuesday announced 412 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Tuesday reported eleven additional deaths in New Mexico related to COVID-19:

Ten recent deaths:

- A female in her 50s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A male in his 50s from Bernalillo County. The individual was hospitalized and had underlying conditions.
- A female in her 80s from Bernalillo County. The individual was a resident of the MorningStar Memory Care facility at North Ridge in Albuquerque.
- A female in her 90s from Bernalillo County. The individual was a resident of the Casa del Norte in Albuquerque.
- A female in her 40s from Cibola County. The individual had underlying conditions.
- A female in her 60s from Grant County. The individual was hospitalized and had underlying conditions.
- A female in her 70s from Lincoln County. The individual was hospitalized and had underlying conditions.
- A female in her 60s from San Juan County. The individual was hospitalized and had underlying conditions.
- A male in his 60s from Santa Fe County. The individual was hospitalized and had underlying conditions.
- A male in his 70s from Tarrant County. The individual was hospitalized and had underlying conditions.

One\* deaths >30 days:

- A male in his 70s from Valencia County. The individual was hospitalized and had underlying conditions.

The number of deaths of New Mexico residents related to COVID-19 is now 4,700.

\*COVID related deaths are reported when a death certificate has been issued and some death certificates are delayed due to insufficient information.

As of today, there are 369 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

As of today, there are 216,137 COVID-19 cases designated as having recovered by the New Mexico Department of Health.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact tracing and swabs of symptomatic individuals who have had contact with the positive cases.

Every New Mexican must work together to stem the spread of COVID-19. Wear a mask when in public and around others. **If you are sick, stay home as much as possible.**

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
