## New Mexico COVID-19 update: 788 new cases, totaling 332,975

Seven additional COVID-19 deaths, 7-Day positivity rate 10.6%

SANTA FE – New Mexico state health officials on Tuesday announced 788 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

The Department of Health on Tuesday reported seven additional deaths in New Mexico related to COVID-19:

- A female in her 80s from Curry County. The individual had underlying conditions and was a resident of the BeeHive Homes Clovis facility.
- A female in her 90s from Doña Ana County. The individual was a resident of the Village at Northrise Desert Willow facility in Las Cruces.
- A male in his 80s from Otero County. The individual was a resident of the Casa Arena Blanca Nursing Center in Alamogordo.
- A male in his 50s from Rio Arriba County. The individual was hospitalized.
- A male in his 80s from San Juan County. The individual was hospitalized and had underlying conditions.

• Western New Mexico Correctional Facility in Cibola County: 79 As of today, there are 666 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact-tracing and swabs of symptomatic individuals who have had contact with the positive cases.

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
