New Mexico COVID-19 update: *5,547 new cases, totaling 393, 736

Thirty-six additional COVID-19 deaths, 7-Day positivity rate 27.8%

***Please note: Today's reporting is back to normal. Case counts are all current.**

SANTA FE – New Mexico state health officials on Thursday announced 5,547 additional COVID-19 cases. Per the state Department of Health, the most recent cases are:

As of today, there are 609 individuals hospitalized in New Mexico for COVID-19. This number may include individuals who tested positive for COVID-19 out of state but are currently hospitalized in New Mexico. This number does not include New Mexicans who tested positive for COVID-19 and may have been transferred to a hospital out of state.

The New Mexico Department of Health has active investigations into the positive patients, which includes contact-tracing and swabs of symptomatic individuals who have had contact with the positive cases.

Every New Mexican must work together to stem the spread of COVID-19. Wear a mask when in public and around others. **If you are sick, stay home as much as possible.**

New Mexicans who report symptoms of COVID-19 infection, such as fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell should call their health care provider or the NMDOH COVID-19 hotline immediately (1-855-600-3453).

The Department of Health strongly encourages the following groups to get tested:

- Symptomatic people displaying the COVID-19 symptoms of fever, cough, shortness of breath, chills, repeated shaking with chills, muscle pain, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, and/or loss of taste or smell;
- Asymptomatic people who are close contacts or household members of people in their infectious period who have already tested positive for the coronavirus;
- Asymptomatic people who live or work in congregate settings such as long-term care facilities and group homes;
- Patients who are scheduled for surgery and whose provider has advised them to get tested before the procedure.
