### **Interstates:**

#### **I-25, Mile Marker 16, Radium Springs**

Highland Enterprises Inc. (Contractor) will begin litter cleanup efforts in Dona Ana Co. Starting Monday, April 18, 2022, crews will begin litter collection along I-25 near Leasburg and will be working south towards Las Cruces. Contractor will be working in 5 miles stretches, Monday through Friday from 7 a.m. to 5 p.m. Help keep our crews safe, give them a brake, reduce your speed, and move over for emergency flashers.

#### **I-25, Mile Marker 34 to 39, Rincon** [CN1101021](#)

Mountain States Constructors, Inc. (Contractor) is continuing with the roadway reconstruction project on I-25 north of Las Cruces. All traffic has been shifted into the northbound bound lanes utilizing crossover detour and barrier wall separation so southbound construction can begin. The southbound Rincon on and off ramps will be closed, follow detour signage. This closure is expected until summer 2022. Hours of operation will be from 7 a.m. to 5 p.m., Monday through Friday. Traffic control will remain in place 24/7.

#### **I-25, Mile Marker 14 to 24, North of Las Cruces** [CN1101610](#)

Mesa Verde Enterprises, Inc. (Contractor) will be continuing a roadway reconstruction project on Interstate 25 from milepost 14 to 24, just north of Las Cruces. Crews will be working in the northbound right driving lane from milepost 14 working north. Drivers can expect various daytime lane closures on both the northbound and southbound lanes as needed. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Saturday.

#### **I-25, Mile Marker 117 & 121, North of Truth or Consequences** [CN1101580](#)

Hasse Contracting Co. will be making repairs to the bridges on I-25 at milepost 117 and milepost 121. Traffic can expect lane closures on I-25 on the southbound lanes until the bridge deck repairs are complete, one lane will remain open. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m., traffic control will remain in place 24/7. Use caution for workers and equipment in the area. Repairs are expected to be completed by summer 2022.

#### **I-10, Mile Marker 24.9 to 35, Lordsburg** [CN1101600](#)

Mountain States Construction, Inc. (Contractor) will be completing a pavement preservation project on I-10 from milepost 24.9 (Lordsburg East) to milepost 35. Starting Monday Apr. 18, drivers can expect lane closures on both the eastbound and westbound lanes as needed for the placement of Rubberized Open Graded Friction Course (ROGFC) which is a pavement sealant. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Friday. Construction is expected to be completed spring of 2022.

#### **I-10, Mile Marker 21 to 23, Lordsburg**

AUI, Inc. (Contractor) will begin finalizing the roadway reconstruction and bridge replacement project in Lordsburg. Traffic is rerouted onto the eastbound and westbound right driving lanes. Contractor will be replacing sidewalk, curb & gutter along Main St., use caution in the area. Contractor hours of operation are from 7 a.m. to 5 p.m., Monday through Friday.

### **I-10, Mile Marker 15 to 20, Lordsburg** CN1101620

Mountain States Construction, Inc. (Contractor) will be continuing reconstruction project on I-10 from milepost 20 (Lordsburg West) to milepost 15 (Gary). The contractor is currently working on replacing guardrail and concrete wall barrier along the project. Paving is complete at this time. Drivers can expect various lane closures on both the eastbound and westbound lanes and overnight as needed. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Friday.

### **US Roadways:**

#### **US 180, Mile Marker 47 to 67, Glenwood**

Dustrol, Inc. (Contractor) will begin a Hot-In-Place Recycling project along US 180 near Glenwood, NM. Starting, Monday, Apr. 25, 2022, traffic can expect lane closures beginning at milepost 47 (Catron Co. Line) working south to milepost 67 (US 180 & NM 78 intersection). A pilot car operation will be in place, please reduce your speed and obey traffic control devices. Work will take place daily from 7 a.m. until 7 p.m. except for Wednesday, April 27 due to the Tour of the Gila bike race. Construction is expected to take 13 days to complete, weather pending.

#### **US 70, Mile Marker 144 to 162, Las Cruces**

A-Mountain Construction (Contractor) will be completing a safety improvement project along US 70 from Picacho Ave at the Rio Grande River to the town of Organ. This project includes the replacement of sidewalks, curb & gutter, driveway pads and attenuators abutments at spot locations. Crews will have various lanes closures in place from Porter to Del Ray and at Picacho & Main. Construction hours will be from 7 a.m. until 5 p.m., Monday through Friday. This project is expected to be completed by Friday, April 22, 2022.

#### **US 60, at Mile Marker 108 and 112, Magdalena**

Hasse Contracting Co. (Contractor) will be continuing with Bridge Preservation projects in Southwest, NM. Bridges located on US 60 west of Magdalena at milepost 108 and in the town of Magdalena at milepost 112. This preservation project is expected to be complete by the end of April. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. Use caution for workers and equipment in the area.

### **State Roadways:**

#### **NM 187, Mile Marker 11 to 12, Derry**

The New Mexico Department of Transportation (NMDOT) District One will be assisting Elephant Butte Irrigation District (EBID) with a pipe replacement on NM 187 just south of Derry, NM. Starting Monday, Apr. 18, 2022, the NMDOT will be closing NM 187 at milepost 11.0 to 11.8 for a culvert pipe replacement. Detour will be in place on Two Counties Rd. and NM 436 "Loma Parada Rd". This closure is estimated to be in place for two weeks reopening on or about Apr. 29, 2022.

#### **NM 169, Mile Marker 0 to 1, Magdalena**

Hasse Contracting Co. (Contractor) will have lane closures in place on NM 169 over the Arroyo Gato for epoxy injection and concrete repairs. Traffic can expect lane closures and unmanned traffic stopping devices. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. This closure is estimated to be in place for two weeks reopening on or about Apr. 29, 2022.

#### **NM 11, Mile Marker 34 to 5, Deming to Columbus**

The New Mexico Department of Transportation (NMDOT) District One be continuing Fog Sealing on NM 11 "Columbus Hwy" from milepost 34 (Florida St.) to 5 (Transfer St. rd.) just north of Columbus. Lane closures will be alternating in either the northbound or southbound lanes. A pilot car operation will be in place. Use caution for workers and equipment in the area. No center stripe and speed limits will be reduced. Working hours are Monday through Thursday from 8 a.m. to 5 p.m.

#### **NM 140, Mile Marker 0 to 1, Rincon** CN1101580

Hasse Contracting Co. (Contractor) will be continuing the Bridge Preservation projects in Southwest, NM. NM 140 is closed from milepost 0 to 1, a detour is in place. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. Use caution for workers and equipment in the area. Bridge is expected to be closed until April 30, 2022.

#### **NM 273 Mile Marker 2, Sunland Park**

The New Mexico Department of Transportation (NMDOT) has a lane closure in place for the City of Sunland Park due to required roadway repairs on NM 273 "McNutt Road" at milepost 2. The driving right lane is expected to be closed through May 2022. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area.

**NM 404 and I-10 Bridge Replacement, Anthony E100202**

AUI, Inc. (Contractor) is continuing with roadwork and replacement of the NM 404 Bridge over I-10 at milepost 162, Anthony exit. Traffic is currently using new bridge as Contractor constructs the other half of the bridge. Please follow detour signage in the area, expect delays. Traffic is open to one lane in each direction. Due to scheduling contractor will be working 7 days a week, 24 hours a day as needed. Traffic control will remain in place 24/7.

**Frontage Road 1035 “Stern Drive” Mile Marker 4 to 6, Las Cruces**

The New Mexico Department of Transportation (NMDOT) will have lane closures and shoulder work in place for erosion control measures along Stern Dr. from milepost 4 to 6. A flagging operation will be in place. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area.

**City of Las Cruces Projects:**

**Peachtree Hills Road**

Peachtree Hills Road between Sonoma Ranch Boulevard and Metro Park Street has been opened to two-way traffic. Temporary traffic control and lane merges in the roadway alignment remain in place. Motorist are urged to obey all placed warning signs.

**Magdalena Drive**

Magdalena Drive is scheduled to undergo roadway improvements by Caliper Construction Company, Inc. as part of the Magdalena Pond Repair Project. The following lane closure will be in place. Traffic on Magdalena Dr. has been shifted to the east, with two lanes of traffic opened southbound and northbound. Crews are working on the shoulder of Magdalena Dr. between the San Miguel Ct. and Borroughs. This lane closure is estimated to last approximately 9 weeks depending on weather conditions. Work will take place between 7 a.m. and 3 p.m., two-way traffic will be maintained.
