*Traffic Report for week of **May 22 to 29, 2022***

*In all construction zones, motorists are asked to reduce speed, obey posted signs, and use extreme caution, as well as continue to be cautious of heavy equipment and construction personnel in the area. **PLEASE NOTE:** Conditions are subject to change without notice. Double fines for speeding in work zones may be in effect.*

Interstates:

I-25, Mile Marker 85 to 103, north of T or C

J-H Supply, Inc. (Contractor) will be replacing the guardrail and end treatments along I-25 in Sierra County. Traffic can expect lane closures in the northbound and southbound driving right lane and shoulder as the contractor is performing these safety improvements. Overnight lane closures will be in place as needed. Hours of operation will be from 7:00 am to 5:00 pm, Monday through Friday. Construction is expected to be completed by fall 2022.

I-25, Mile Marker 34 to 39, Rincon CN1101021

Mountain States Constructors, Inc. (Contractor) is continuing with the roadway reconstruction project on I-25 north of Las Cruces. All traffic has been shifted into the northbound lanes utilizing crossover detour and barrier wall separation so southbound construction can begin. The southbound Rincon on and off ramps will be closed, follow detour signage. This closure is expected until summer 2022. Hours of operation will be from 7 a.m. to 5 p.m., Monday through Friday. Traffic control will remain in place 24/7.

I-25, Mile Marker 14 to 24, North of Las Cruces CN1101610

Mesa Verde Enterprises, Inc. (Contractor) will be continuing a roadway reconstruction project on Interstate 25 from milepost 14 to 24, just north of Las Cruces. Crews will be working in the northbound and southbound lanes; one lane will remain open at all times. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Saturday.

I-25, Mile Marker 117 & 121, North of Truth or Consequences CN1101580

Hasse Contracting Co. will be making repairs to the bridges on I-25 at milepost 117 and milepost 121. Traffic can expect lane closures on I-25 on the southbound lanes until the bridge deck repairs are complete, one lane will remain open. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m., traffic control will remain in place 24/7. Use caution for workers and equipment in the area. Repairs are expected to be completed by summer 2022.

I-10, Mile Marker 15 to 20, Lordsburg CN1101620

Mountain States Construction, Inc. (Contractor) will be finalizing the reconstruction project on I-10 from milepost 20 (Lordsburg West) to milepost 15 (Gary). Drivers can expect lane closures on both the eastbound and westbound lanes as needed for the placement of Rubberized Open Graded Friction Course (ROGFC) which is a pavement sealant. Contractor will be continuing with replacing guardrail and concrete wall barrier along the project. Contractor's hours of operation will be from 6 a.m. to 6 p.m., Monday through Friday.

US Roadways:

US 70, Mile Marker 152 to 153, Las Cruces

El Paso Electric Company will have nighttime closures in place on US 70 between Rinconada Ave. and Sonoma Ranch Blvd. for the placement of overhead power lines. Overnight work will begin on Tuesday, May 24, to Friday, May 27, 2022, from 10 p.m. until 7 a.m. All eastbound and westbound traffic will be detoured onto the Bataan

Memorial Frontage Road with one lane of travel open in each direction. Speed limits will be reduced. This closure is in place for the safety of the traveling public and employees.

US 180, Mile Marker 114 to 115, Silver City CN1101450

James Hamilton Construction Company (Contractor) has completed roadwork at the intersection of US 180 and 32nd. Street. Traffic can expect a lane closure as needed for final punch list items. Contractor hours of operation will be Monday through Friday from 7:00 a.m. till 5:00 p.m. This project is estimated to be completed by June 3, 2022.

US 180, Mile Marker 47 to 67, Glenwood

Dustrol, Inc. (Contractor) will be continuing a Hot-In-Place Recycling project along US 180 near Glenwood, NM. Traffic can expect lane closures beginning at milepost 47 (Catron Co. Line) working south to milepost 67 (US 180 & NM 78 intersection). A pilot car operation will be in place, please reduce your speed and obey traffic control devices. This project has a 12-foot width restriction. Work will take place daily from 7 a.m. until 7 p.m. Construction is expected to be completed by June 3, 2022, weather pending.

US 60, at Mile Marker 108, Magdalena

Hasse Contracting Co. (Contractor) will be continuing with a Bridge Preservation project in Southwest, NM. The bridge located on US 60 west of Magdalena at milepost 108 will have shoulder work in place. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. Use caution for workers and equipment in the area.

State Roadways:

NM 136, Mile Marker 7.5, Santa Teresa

Rt Electric (Contractor) will be installing a new traffic signal at the intersection of NM 136 “Pete Domenici Blvd” and Russell Blvd. Contractors working hours are Monday through Friday from 7 a.m. to 4 p.m. This project is expected to be completed by June 3, 2022.

NM 187, Mile Marker 1.3 to 9, from Hatch to Garfield

Sacred Wind Communications (Contractor) will have shoulder work in place on NM 187 from milepost 1.3 to 9 for Utility work. Contractors working hours are Monday through Friday from 7 a.m. to 5 p.m. This project is expected to be completed by June 2, 2022.

NM 28, Mile Marker 26 to 27, San Pablo

Smith & Aguirre Construction Co. (Contractor) will be continuing roadwork along NM 28 near the Craver Rd intersection. Crews will be widening NM 28 and adding in a turning lane at this intersection. Speed limit will be reduced to 35 miles per hour. Working hours are Monday through Friday from 7 a.m. until 5 p.m. Project is estimated to be completed on June 3, 2022.

NM 169, Mile Marker 5 and 16, Magdalena

Hasse Contracting Co. (Contractor) will have lane closures in place on NM 169 near milepost 5 and at milepost 16 for bridge repairs. Traffic can expect lane closures and unmanned traffic stopping devices. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. This closure is estimated to be in place for two weeks reopening on or about summer 2022.

NM 11, Mile Marker 34 to 5, Deming to Columbus

The New Mexico Department of Transportation (NMDOT) has completed Fog Sealing operations on NM 11. Striping is scheduled to take place in the next few weeks, use caution for no center line and continue with reduced speeds.

NM 140, Mile Marker 0 to 1, Rincon CN1101580

Hasse Contracting Co. (Contractor) will be continuing a Bridge Preservation projects on NM 140. NM 140 is closed from milepost 0 to 1, a detour is in place. Contractor working hours are Monday through Friday from 7 a.m. to 5 p.m. Use caution for workers and equipment in the area. Bridge is expected to be closed until June 10, 2022.

NM 273 Mile Marker 2, Sunland Park

The New Mexico Department of Transportation (NMDOT) has a lane closure in place for the City of Sunland Park due to required roadway repairs on NM 273 “McNutt Road” at milepost 2. The driving right lane is expected to be closed through May 2022. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area.

NM 404 and I-10 Bridge Replacement, Anthony E100202

AUI, Inc. (Contractor) is continuing with roadwork and replacement of the NM 404 Bridge over I-10 at milepost 162, Anthony exit. Traffic is currently using new bridge as Contractor constructs the other half of the bridge. Please follow detour signage in the area, expect delays. Traffic is open to one lane in each direction. Contractor hours will be Monday through Friday from 7 a.m. to 6 p.m. Traffic control will remain in place 24/7.

Frontage Road 1035 “Stern Drive” Mile Marker 4 to 6, Las Cruces

The New Mexico Department of Transportation (NMDOT) will have lane closures and shoulder work in place for erosion control measures along Stern Dr. from milepost 4 to 6. A flagging operation will be in place. Motorists are asked to reduce speed, obey posted signs, and be cautious of personnel and equipment in the area.

Chip Seal Projects, Grant Co:

The New Mexico Department of Transportation (NMDOT) will be performing “Chip Sealing and Brooming” operations in Grant Co. Speed limits will be reduced, no center stripe with loose gravel on roadway. Traffic will encounter lane drops with pilot car and flagging operations.

Roadways affected will be:

State Park Road City of Rocks, intersection of NM 61 to Park entrance

NM 61, milepost 0 to 25, Intersection of US 180 to intersection on NM 152

Wildfire Roadway Closures:

The following road closure is in place. Please be advised that this route is open for evacuation only, no reentry is allowed.

NM 59 “Beaverhead Rd.” is closed between mileposts 0 (Jct. of N.M. 52 and N.M. 59) and 31, end of State route.

City of Las Cruces Projects:

Peachtree Hills Road

Peachtree Hills Road between Sonoma Ranch Boulevard and Metro Park Street has been opened to two-way traffic. Temporary traffic control and lane merges in the roadway alignment remain in place. Motorists are urged to obey all placed warning signs.

Sonoma Ranch Boulevard

As part of the Sonoma Ranch Boulevard Mile 1 Construction Project, shoulder work is scheduled on Sonoma Ranch Boulevard, between Sierra Ventana Avenue and Peachtree Hills Road. The shoulder work is expected to last through approximately July 8, 2022. Additionally, a temporary roundabout is in place at the intersection of Sonoma Ranch Boulevard and Engler Road. Motorist are urged to obey all placed warning signs.
