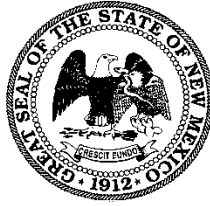

## **PRC Nominating Committee conducts first set of interviews with Commissioner candidates**

SANTA FE, N.M. – The New Mexico Public Regulation Commission (PRC) Nominating Committee today conducted its first set of interviews with applicants for the position of Commissioner, meeting with H. Ward Camp (Independent from Bernalillo County), Kenneth Costello (Independent from Santa Fe County), Cynthia B. Hall (Democrat from Bernalillo County), and Arthur O'Donnell (Independent from Bernalillo County). The Committee will continue to interview applicants during its next two regular meetings on November 7 and November 8, before making its final recommendations to Governor Michelle Lujan Grisham on November 14.

The bipartisan Nominating Committee is tasked with evaluating applicants to fill vacancies on the Commission, which will transition from an elected body to an executive-appointed panel to begin staggered six-year terms on January 1, 2023. For the next class of Commissioners, the Committee will recommend five candidates to Governor Lujan Grisham, who will then appoint three of them to serve on the new Commission, subject to approval by the state Senate.

The Nominating Committee's list of recommended candidates must include applicants from at least three different counties in New Mexico. The new Commission may not include more than two members from the same political party.

The remaining applicants (with political affiliation and county/state of residence) scheduled to interview with the Nominating Committee on either November 7 or November 8 are as follows:

- Amy L. Stein, Democrat, Bernalillo County

- Carolyn Glick, Independent, Santa Fe County
- Cholla Khoury, Democrat, Bernalillo County
- Glen Lyons, Independent, Texas

- Joseph Little, Democrat, Bernalillo County
- Patrick O'Connell, Democrat, Bernalillo County
- Scott Karns, Republican, Santa Fe County
- James Ellison, Independent, Bernalillo County
- Brian Moore, Republican, Union County

The Commission is both the governing body for the PRC as well as a policy and regulatory body. The Commission's duties include setting rates, creating policy that implements statutory mandates and policy goals, and enforcing rules and regulations governing regulated entities. A principal function of the Commission is to adjudicate cases involving regulated entities.

Nominating Committee meetings take place in Room 309 at the State Capitol and are also available for viewing online on the New Mexico Legislature website. Public comment from stakeholders, including private citizens, is highly encouraged.
